## Introducing Aptos threads

Allowing doctors to achieve the effects of plastic surgery without anaesthesia, incisions or long recovery periods, it was a revolutionary product in the field of aesthetic medicine.



## A unique choice

APTOS is unique in their range of threads as well as the composition and creation of their product. Absorbable materials, P(LA/CL), are used for the majority of APTOS threads, allowing results to last from 1.5 to 2 years.

Poly-lactic acid is a chemical stimulant for collagen formation, resulting in rejuvenation of the skin, and Caprolactone maintains the integrity of the thread, thereby extending its lifetime.

Aptos also has permanent threads made from polypropylene, and these results can last an impressive 2 - 5 years.
